## GATE TRANSMITTERS

1. A deposit of \$30.00 per allowable leased Gate Transmitter will be required.
2. If a Gate Transmitter is lost, stolen, or destroyed, the \$30.00 deposit will be forfeited. Additionally, a \$100.00 fee will be assessed.
3. After payment of the \$100.00 fee for a lost, stolen or destroyed Gate Transmitter, a new transmitter may be leased for a deposit of \$30.00.
4. If a Gate Transmitter stops working during the first 90 days, through no fault of the lessee and is returned to the Woodside office, a new transmitter will be given to the owner/tenant. The original \$30 deposit will remain on the account.
5. Upgrade charge to a new transmitter is \$25.00; the \$30 deposit will remain on the account.
